
Glossary of Terms: Alpha measures the difference between a fund's actual return and its level of risk as measured by beta. Beta measures the Fund's volatility relative to the overall market. EPS Growth (3-5 Year Estimate) is the portion of a company's profit allocated to each outstanding share of common stock. Information Ratio measures the returns above the returns of a benchmark to the volatility of those returns. **Price to Book (trailing 12 months)** calculates the ratio of a stock's price to its book value. Price to Cash Flow is the ratio of a stock's price to its cash criterion. Investments with 0 points are automatically given an Fi360

flow per share. Price to Earnings (next 12 months) calculates the price of a Fiduciary Score® of 0. Every other investment is given a Score of 1-100 stock divided by its earnings per share. ROA is an indicator of how profitable a company is relative to its total assets. R-Squared is the way in Fi360 Fiduciary Score® should not be used as the sole source of which a percentage of a portfolio's total returns represents the portfolio's beta measure. The weights are: 100% three-year rating for 36-59 months of total returns, 60% five-year rating/40% three-year rating for 60-119 months of total returns, and 50% 10-year rating/30% five-year rating/20% three-year rating for 120 or more months of total returns. While the 10-year overall star rating formula seems to give the most weight to the 10-year period, the most recent three-year period actually has the greatest impact because it is included in all three rating periods.
